## **Data Protection Guides for Parents/Guardians**

The Data Protection Commission (DPC) has recently published four short guides for parents/guardians on children's data protection rights under the GDPR. These guides are intended to help parents/guardians to understand their children's rights and to answer questions that can arise in typical situations where those rights apply.

This will help to ensure that more parents/guardians have the opportunity to read them and learn about their children's data protection rights. The DPC hopes that these guides will also be useful to educators and anyone interested in children's safety and wellbeing online.

#### My child's data protection rights - the basics

• This outlines some of the issues that can arise when a parent/guardian seeks to exercise data protection rights on behalf of their child.

### Children's data and parental consent

This looks at the meaning of the 'age of digital consent' and outlines when parents' /guardians' consent may be needed for processing their child's personal data, and how parents/guardians can approach those cases.

### Protecting my child's data

This is intended to help parents/guardians understand the rights that they have in relation to their children's data and gives some useful advice on how to protect their children's rights.

#### Are there any limits on my child's data protection rights?

This outlines some important limits to how and when children's data protection rights may be exercised, whether by children themselves or by parents/guardians on their behalf. It outlines some common situations where these can arise and suggests ways in which parents/guardians can address them.
